Bar terms: all beer/liquor/soda must be purchased through the KCs for the reception, 2 cases of *champagne (not wine)* may be brought in; there is a 2-keg limit and kegs will be shut off at 9:00pm, there will be *no bottles on the tables at any time*, no drinks may be carried in or out of the hall, all drinks from the start of the reception to the finish will be served in plastic cups - there will be no pitchers, Knights of Columbus will furnish bartenders for all events, the Carroll Club are always the beneficiary of the bar proceeds.

All kegs ordered will be charged regardless of quantity used. No alcoholic beverages will be served to anyone under 21 at any time.

All events will end at 1:00 A.M. The band must stop at 12:00 midnight but the bar may stay open until 1:00 AM. All decorations and items must be removed at the end of the event, and key returned to slot on door behind kitchen. Arranging of tables must be so that exit aisles are left open. Paid rental of main hall includes use of kitchen facility but does not provide dishes, servingware, or other kitchen items. Knights of Columbus are not responsible for lost or stolen decorations/belongings and no decorations or lights will be provided by the KCs.
